



# Ecommerce Cash on Delivery International Courier -

delivery of goods with **COD (cash collect on delivery)** in Romania and in European Union

The mentioned service refers to the shipment of goods (parcels) from Romania, to Romania or the mentioned European destinations, the transport of these shipments by road and their delivery with the collection from the recipient of the amounts indicated by the sender. The shipment will not be delivered when the recipient does not pay the amount due by the sender. The amount of the refund is indicated in the currency of the destination country and is transferred in this currency or converted upon request. Undelivered shipments are returned consolidated to the point of origin.

✓ The collected refund amounts are transferred twice a week.

✓ Refunds are transferred only by bank transfer or Paypal, anywhere in the world.

<b>Monthly Volume</b>	The rate refers to shipments sent exclusively from the TCE Fulfillment warehouse.
<b>Weight</b>	Weight - the greater of the volumetric weight / weighed weight is invoiced
